MEMBERSHIP STATUS REPORT

TDNA Board of Directors Meeting July 13, 2006 - Headliners Club, Austin

TDNA expects to receive \$410,103 in member dues for 2006 – \$390,623 from newspapers and \$19,480 from associate members. All other income combined is projected to total \$4,770 for this year. Dues will be almost 99% of this year's projected income.

As usual, over half of the year's dues income had been collected by the end of May from both newspapers and associate members.

As of May 31, newspaper members had paid \$233,989 of the \$389,925 budgeted for the year. Associate member dues received during the same period totaled \$11,160 of the \$19,480 budgeted.

A planned drive to recruit more associate members was not actively pursued last year, but it will be carried out this summer. TDNA staff has been collecting data on potential associate members and will soon begin promoting membership to those firms.

Newspapers

If all current members pay in full, there will be a profit of \$698 in regular newspaper dues income this year.

The 2006 proposed budgeted approved by the board did not levy a dues increase.

One newspaper joined this year, *The River Cities Daily Tribune* in Marble Falls, paying annual dues of \$698.12.

Since *The Katy Courier* began publishing, and *Rumbo de Austin* went out of business, there are currently 14 non-member daily papers in Texas. The list that follows this report contains publisher names, phone numbers, ownership, membership history, and amount of dues.

Associates

There is one new member so far this year – <u>Sedgwick, Detert, Moran & Arnold, LLP</u> a new Austin office of the worldwide firm.

Some associate members are billed for the year beginning the month they joined, so not all associates have been billed for 2006 dues.

Another new member – the Texas Press Association – became a member at the first of the year and that membership was approved at the December board meeting. TPA and TDNA have exchanged complimentary associate memberships.
