
This is to extend my personal invitation to you to visit our South Texas military facilities located in my Congressional District. These facilities have and continue to fulfill critical national defense and homeland security needs. As you know, my Congressional District will be severely impacted if the Department of Defense (DoD) recommendations to close Naval Station Ingleside and disestablish the Mine Warfare Center of Excellence; realign Naval Air Station Corpus Christi; and realign Corpus Christi Army Depot are implemented.
