At this meeting they also performed the "Broken Arrow" Ceremony for Everett Delashmutt, (one of their members who had recently passed). It is quite an impressive ceremony with the reading of the person's full life story in detail. Also at this meeting was a brief review of the revolutionary Battle of Eutaw Springs in the Carolinas and its somewhat humorous ending by the Chapter Historian, and the short talk on an ancestor's biography by one of the members. There was a brief business meeting to inform all attendees on the chapter status and upcoming events. SAR President David Temple gave a talk on the various currencies issued and used during the war of independence and the struggle of Robert Morris to provide funds and supplies for the continental forces. By the end of the war Robert Morris had used all of his personal fortune in this endeavor and was completely without any money of his own.

Awards, Veterans Projects, Recognition of Good Citizenship & Acts of Heroism, and Awards for Outstanding Police and Firemen with emphasis on recruiting new members.

Summary

I am able to attend most of the District 6 Chapter meetings. Meetings are well attended, well organized and efficiently run with interesting speakers. Committee reports on past and upcoming events maintain interest and activity.

My last report mentioned a District wide problem in reporting the Public Service and Heroism Commendations. The proper reporting procedures were discussed with the three chapters and also discussed at the District 6 Meeting. District 6 should now show improvement is this reporting process.

The three District 6 Chapters maintain websites. Dallas and East Fork-Trinity publish monthly newsletters. Dallas, Plano, and East Fork-Trinity all maintain web sites and all have a Facebook page. The Dallas Chapter publishes meetings and other notable events on You Tube. All District 6 chapters have active Color Guards. Many chapter level events occur monthly with standing invitations for all SAR to attend. There is great Color Guard cooperation between all Chapters and Districts.

The interest and activity levels in District 6 are great.

Annual support of and cooperation with local DAR Chapters continues, most notably with the Jane Douglas Chapter's invitation the SAR during State Fair to their Continental House for the purpose of public relations and recruitment.

The Continental House constantly needs maintenance. At the 2019 State Convention DAR Liasion Tom Green brought from Committee a motion to contribute \$1000.00 for building maintenance to the Jane Douglas Chapter. The motion was approved on the Convention Floor and the donation has been

made. It is my hope that this level of support can increase in the future, or at a minimum be continued. While this event is located in North Texas, the entire Texas Society benefits from this public exposure. The State Fair of Texas is attended by Texans from all over the State...even some non-Texans from out of state attend.

Plans are being made for the 2021 State Convention. Plano and East Fork- Trinity will be co-sponsors. Location is the Hyatt Regency 701 East Campbell Road, Richardson Texas, 75081.

Member retention remains to be, at least in my view, the SAR's most pressing issue. A quick review of the statistics listed above show District 6 with 66 new inductions in the previous year, but only 18 member increase.

27% retention.

This is also a state wide issue. Feb 2019 roster show a statewide membership of 2379. We show 361 new members inducted. January 28, 2020, roster shows statewide membership of 2544. We inducted 361 new members, resulting in a net membership increase of 165. 45% retention.

I still do not have a solution for this problem. Suggested solutions: 1) Get and keep new members involved with chapter activities, committee membership is a good beginning. 2) Try to interest family members, WOSAR's in attendance at chapter meetings are a great asset. 3) Children and grandchildren are a source of new members we cannot afford to overlook.

4) Chapter mentoring.

District 6 has some issues, but we have competent Compatriots working on these issues. All three District 6 Presidents for 2019 are repeating in 2020. This greatly adds to the stability of the Chapters 2, 37, and 47, and to District 6.

District 6 is solid.

It has been my honor and privilege to serve as Vice President, District 6 for the past few years. I am confident of the continued success of this District and the Texas Society, Sons of the American Revolution!

Overall District 11 has had a steady growth in participation and membership. New members have been added to all chapters in the district. More time has been spent with some chapters than others. Each of the Chapters Presidents were asked to submit their goals for 2020. I plan on using some of their ideas in increasing membership and helping all chapters in the district achieve their goals. When possible the DAR has helped in increasing the SAR numbers this past year, and medals will be presented to those who helped increase the SAR membership. In an attempt to get more members involved in the SAR I have challenged each chapter to send one person to the Bonham VA on June 23rd (11-1) to serve pre- July 4th dinner to the Veterans. Also, December 10th (9-12) to hand out Christmas gifts to the Veterans. Each Chapter had been challenged to present 10 Flag Certificates for the year, and look at doing one of the youth programs.

With the help of Mike Connelley, we now have new officers in the Denton Chapter and they are meeting quarterly. They wish to continue doing ROTC and JROTC recognizing and

issue Flag Certificates in the Denton area. There are plans to do something with the DAR during Constitution week. They have been able to contact some of those who were approved for membership in the past and presented their certificates to the, At the meeting in January 2020 there were plans to induct two new members. Their web site has been changed and can be accessed via the Texas web site. It has new information about the chapter. Mike has plans to work with Veteran within the chapter and get them involved with Veterans. He plans on pushing the Youth Contests and has created a "New Member" handout hoping to get new members more involved. Along with this there are members inquiring as to where to get a uniform. A report from the registrar says they have seven new application in the pipeline.

The McKinney Chapter continues to grow and add new members. In 2019, they added 24 new members and 4 junior members. They did loose two of their members in the same year. The Edmund Terrill Chapter was hit the hardest with four deaths in 2019; however they have gained some new members to compensate for the losses. New officers were installed in January for 2020 – 2022. The chapter was not able to accomplish everything in 2019 that it would like to have. It was able to move forward and continue its prior path. It increased the issue of Flag Certificate over the past few years and hopes to keep that movement going forth. With the new officers came some new goals for the chapter plus others presented by the District 11 VP. At least two of the new members are looking to make a complete uniform for themselves. They will joining forces with the McKinney Chapter in hosting the BOM for 2020.

Red River Valley Chapter in Paris, TX did not meet for most of 2019 as their President had a stroke and was recovering. This drew a concern from the State, District, and Chapter as to what it was going to do. That was addressed at a meeting in February of 2020, among the members present (12 members and 3 guests from Edmund Terrill). It was decided that they would meet every other month alternating day and evening. Thus this give all members a chance to attend a meeting. They are in hope that this will keep. their membership active. The also had concerns about who is notified when an application is rejected and what should be done. Bill Hurst and T.L. Holden addressed these problems for them. They will be installing a new member at their next meeting. They would like to do more publicity in the East Texas area in hope of getting some new member. Even though Dr. Grubb's is paralyzed on the right side he still has a sharp mind.

Ambassador Fletcher Warren Chapter in Greenville, TX, still has its problems. No one wants to lead plus a lot of the past members are no longer in the area or their age keeps them

from getting out for a meeting. The current President Delbert Frances moved to Justin, TX, and will join the Denton Chapter. I will be getting the Chapters uniform back from him and returning it to Greenville as it was given to the chapter by a past member. I am working with the Chapter Treasurer to get somethings that are the Chapter's history. My plans are to do more work in the area to increase membership. This would include using the Libraries in Greenville and Sulpher Spring. Information on the area indicates there are a number of things to get involved with there.

Trustee – Thomas Jackson

November, 2019 through Spring Leadership 2020

Although there was some committee communication, the majority of my work as trustee was conducted at Spring Leadership in Louisville from February 27-February 29. The meeting started promptly at _____ and had the standard greetings and presentation of gifts.

PG Tomme reported on the database update, noting that chapters and states would be reporting medals awarded into a database. Any medals which were inappropriately awarded would be requested to be returned to National from the awardee. Although chapters and states would have their own dashboards, chapters would be required to report all medals to the State Secretary, who would then be required to data input this information. PG White raised a question regarding this and PG Tomme indicated that some states required this. PG Tomme noted that various security fixes had been installed and the new website was in beta testing and hoped that it would be up in several weeks. National dues is in beta testing with three states and one foreign society.

Paul Callaghan reported that the Virginia Congress scheduled for July11 - July 16 registration would go live in mid-May. He anticipated that tours would sell out. If a room is needed, please contact him directly as he may be able to assist. If you need to cancel a room, please contact him and let him cancel. The host reception is at the Library of Virginia and a Wednesday tour is planned featuring a re-enactment of the Patrick Henry debate.

The headquarters building project update was presented. Six minor projects totaling \$30k and one major façade project totaling \$10k were submitted to the trustees for consideration. The trustees voted to approve the projects limited by funding availability.

General Officer reports were submitted.

The Executive Committee report was presented and certain highlights were noted. Pennsylvania is the 2024 Congress site. The Color Guard Safety Policy was approved. The Naming Rights Policy was postponed. The new logo is under review and will be voted on National Congress. Patriot grave marking changes were approved and will be posted on the website. Hillsdale College issued a Cease & Desist order with a return of all documents. The National Society will comply, but noted that over 90% of all documents were in possession of one individual and directed Hillsdale College to contact that individual.

Certain matters were brought before the Trustees for approval:

- 1. Move forward on the next phase of the solid light proposal, subject to financing approved
- 2. Application fee increase to \$100.00 approved
- 3. A damage claim of \$3,000 denied by the insurance carrier and the motion was not to pursue a lawsuit approved
- 4. The investment allocation approved no change
- 5. Musket be deaccessioned. Trustee approved.

Certain matters were discussed on the floor where no action to be taken by the Trustees to include Hillsdale College and the Kings College Project Net Extension.
