Canadian Legislative Context: LAC Act section 8 (2)

- Powers of Librarian and Archivist
- 8 (1) The Librarian and Archivist may do anything that is conducive to the attainment of the objects of the Library and Archives of Canada, including
- Sampling from Internet
- (2) In exercising the powers referred to in paragraph (1)(a) and for the purpose of preservation, the Librarian and Archivist may take, at the times and in the manner that he or she considers appropriate, a representative sample of the documentary material of interest to Canada that is accessible to the public without restriction through the Internet or any similar medium.

Web Archival Acquisition Methodology

- 1. Comprehensive collection of the GC web presence (2005-)
- 2. Thematic web & social media research collections (2009-)
- 3. Events-based collections and news media (2013-)
- 4. Rescue or preservation harvesting (2005-)
- 5. Acquisition of nominated resources (2005-)

Major Historical Events and Impacts on Curation Methodology

- In the early program history (~2011), ad hoc reaction to major events consisted of scrambling to get the best media resources documenting the issues
- We needed a means to get ahead of events (that by nature could not be planned or anticipated)
- In 2016 we began daily harvest of a broad range of news media; this began picking up information on COVID-19 when it emerged in the news in December 2019.

Major Historical Events and Impacts on Curation Methodology (2)

- Project management methodology: define the themes to document within the historical event, by what priority/sequence, scale or degree of comprehensiveness, quality control level
- Allow the scope to evolve over time as the historical event itself warrants / based on he new themes and resources generated
- Reduce the collection of redundant social media across platforms
- Rely on API based social media collection where possible (Twarc)
- Approach the collection of social media by theme; target and collect e.g., the most pertinent hashtags from Twitter by highest traffic

Canadian News Media Collection (2016-)

- Automated collection of news media currently comprises:
 - 335 seeds
 - 4,535 crawls
 - ~656 million objects
 - ~18 Terabytes and growing daily
- Daily news collection captures front page news and supplies an ongoing historical documentation/timeline for major events
- Frees resources to curate and concentrate on selecting nonmedia resources related to a given theme for better ROI





(Web) Archival Finding Aids

- The 'end state' of the web archival scoping document that includes the details of how the initial scope of the project evolved over time
- Published alongside the actual collection (archival practice) to assist digital humanities researchers that use the Web as primary historical source
- Details the end-state of the collection's metadata schema, how it evolved over time to reflect the scoped-in-content, how to use the controlled vocab to search the collection
- Defines what as deliberately excluded (scope-out)
- Enables researchers to see at-a-glance whether the collection or dataset addresses their research questions (without slogging through it by browsing or search)

Program Future State

- Continue collecting information related to COVID-19 in Canada and related issues (as long as it takes...)
- Deploy a new Government of Canada Web Archive access portal in Q3 of 2022-23 (on schedule).
- Expand to Canadian domain crawls (all of .ca).
- Continue to document Canadian perspectives and news media on Ukraine.
