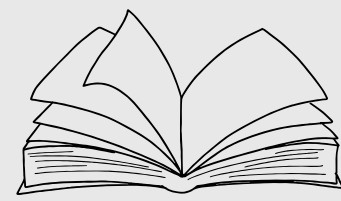
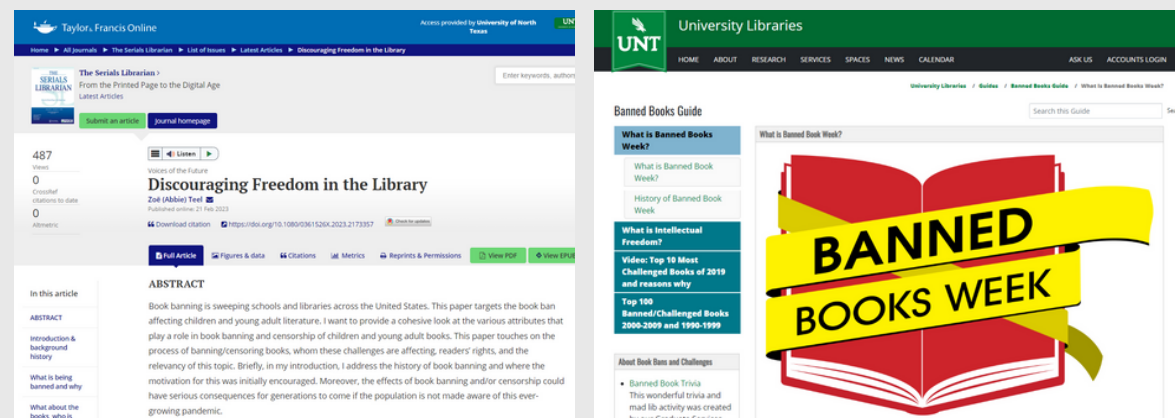


# UNT COMBATS NATIONAL BOOK BAN CRISIS: A GSA PERSPECTIVE

## INTRODUCTION

Academic libraries have been a target of the national book ban crisis. There has been a proliferation of books that have been subjected to censorship in the last few years, especially books that deal with imperative topics such as gender identity, race, abortion, and sexuality. Books authored by individuals who are BIPOC (black, Indigenous, and people of color) are heavily under attack and face unfair, unjust scrutiny.

Libraries are supposed to be the home of information; a place that demolishes barriers and welcomes knowledge. Academic libraries are the embodiment of intellectual freedom. Questioning why things are the way they are is at the heart of education.

"The unparalleled number of reported book challenges in 2022 nearly doubles the 729 book challenges reported in 2021. A record 2,571 unique titles were targeted for censorship, a 38% increase over the 1,858 unique titles targeted for censorship in 2021" (ALA, 2022).

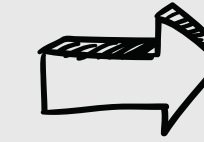


## CORRELATION TO WORK

In February 2023, during my time as a GSA, I published research regarding the book ban. My article, *Discouraging Freedom in the Library* (Serials Librarian Journal) explored the impact of the book ban on students. I touched on the process of banning/censoring books, whom these challenges are affecting, readers' rights, and the relevancy of this topic. Briefly, in my introduction, I address the history of book banning and where the motivation for this was initially encouraged. Moreover, the effects of book banning and/or censorship could have serious consequences for generations to come if the population is not made aware of this ever-growing pandemic.

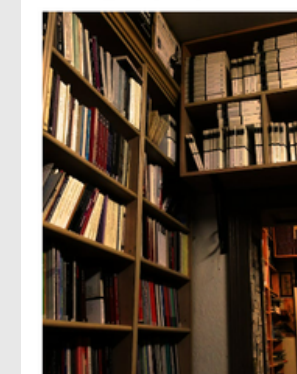
