BASIC FACTS ABOUT THREE FEDERAL OCCUPATIONAL HEALTH AND SAFETY LAWS

The three basic occupational health and safety laws governing the work-related health and safety of most of the nation's non-governmental workers are:

- The Federal Metal and Nonmetallic Mine Safety Act (P.L. 89-577) which establishes procedures for the Secretary of the Interior to promulgate and enforce Federal standards for health and safety in all metal mines and other types of mining operations except.
  (a) coal and lignite mines and (b) natural gas and minerals extracted in liquid form (such as oil), unless the extraction requires the use of underground workers (in which case the mining operation would not be exempt). Examples of the minerals whose extraction is covered by the Act include copper, iron, salt, sulfur, sand and gravel, granite, limestone, and marble.
- 2) The Federal Coal Mine Health and Safety Act of 1969 (P.L. 91-173) which establishes procedures for the Secretary of the Interior to promulgate and enforce Federal standards for health and safety in all coal mining operations affecting interstate commerce.
- 3) The Occupational Safety and Health Act of 1970 (P.L. 91-596) which establishes procedures for the Secretary of Labor to promulgate and enforce Federal standards for health and safety in any business affecting interstate commerce except for (a) an employer over whom a Federal agency other than the Labor Department exercises statutory authority to prescribe standards affecting occupational safety or health, (b) an employer over whom a State agency exercises such statutory authority under the Atomic Energy Act of 1954, and (c) the United States, a State, or political subdivision.

The following are some comparative facts about key elements of these three laws.
